As calculated in accordance with Rule 13d-3 of the Securities Exchange Act of 1934, as amended, (i) Sabby Healthcare Master Fund, Ltd. and Sabby Volatility Master Fund, Ltd. beneficially own 680,000 and 455,000 shares of the Issuer's common stock (Common Stock), respectively, representing approximately 3.90% and 2.61% of the Common Stock, respectively, and (ii) Sabby Management, LLC and Hal Mintz each beneficially own 1,135,000 shares of the Common Stock, representing approximately 6.51% of the Common Stock. Mr. Mintz indirectly owns 1,135,000 shares of Common Stock in his capacity as manager of Sabby Management, LLC.
